When and Where to Vote:

- Election Day is Tuesday, November 6, 2012.
- Polls are open from 6:00 a.m. to 8:00 p.m.

How to Register to Vote:

- To register, print the voter registration form from <http://www.sots.ct.gov/sots/cwp/view.asp?a=3179&q=489908>, and mail it to your local election authority.
- Re-register to vote if you have moved, changed your name, or would like to declare an official party affiliation. If your voter registration information has not changed, you do not need to re-register.
- Mail in registration forms must be postmarked or received by October 22, 2012.
- In person registration must be completed by October 30, 2012 at your local election authority.

What to Bring on Election Day:

- Bring a photo ID with your current address, such as a Connecticut driver's license, your state ID, or a US Passport.
- If you do not have a photo ID with a current address, bring two IDs that contain your name and address, such as a utility bill, a bank statement, a paycheck, etc.
- You cannot be turned away from voting because you did not bring proper identification. If you do not have proper ID, you can use a provisional ballot.

Absentee Voting:

- Absentee voting is available for registered voters that qualify.
- Request an absentee voting application from <http://www.sots.ct.gov/sots/cwp/view.asp?a=3179&q=489910>, and mail it to your local election authority.
- Absentee voting by mail starts on October 6, 2012.
- Ballots must be received by your county board of elections by 8:00 p.m. on November 6, 2012.
- Voters are strongly encouraged to go to the polls to vote if possible.

Early Voting:

- Early voting in person is not available in Connecticut.

Your Rights as a Connecticut Voter are as Follows:

- To vote if you registered by mail and it was postmarked or received by October 22, or registered in person by October 30, 2012.
- To have questions concerning voting procedures answered and to receive assistance if needed.

Due to CAIR's 501(c)3 status, CAIR does not endorse any specific candidate or campaign and cannot give advice about how you should vote.

Major newspapers may produce a guide to candidate positions.



- To vote without being intimidated, threatened, or coerced.
- To vote if you are eligible to do so even if you do not bring an ID to the polls.
- To vote using a provisional ballot if your registration comes into question.
- If you feel that your rights are violated or you witness a violation of rights in the registration or voting process, please contact the Connecticut Legislation & Elections Administration Division at (860) 509-6100.
- Your vote is private – The ballots are processed in such a way that your identity will not be distinguishable from your ballot.
