When and Where to Vote:

- Election Day is Tuesday, November 6, 2012.
- Polls are open from 6:00 a.m. to 8:00 p.m.

How to Register to Vote:

- To register, print the voter registration form from <http://www.nj.gov/state/elections/voting-information-voter-registration-forms.html>, and mail it to your local election authority.
- Re-register to vote if you have moved, changed your name, or would like to declare an official party affiliation. If your voter registration information has not changed, you do not need to re-register.

- Registration must be received by October 16, 2012.

What to Bring on Election Day:

- Bring a photo ID with your current address, such as a New Jersey driver's license, your state ID, or a US Passport.
- If you do not have a photo ID with a current address, bring two IDs that contain your name and address, such as a utility bill, a bank statement, a paycheck, etc.
- You cannot be turned away from voting because you did not bring proper identification. If you do not have proper ID, you can vote using a provisional ballot.

Absentee Voting:

- All registered voters are eligible to vote absentee or by mail.
- Request an absentee voting application from http://www.njelections.org/mail-in_doe.html, and mail it to your local election authority.
- Requests by mail must be received by your local election authority no later October 30, 2012.
- In person requests must be made by 3:00 p.m. on November 5, 2012.
- Voters are strongly encouraged to go to the polls to vote if possible.

Early Voting:

- Early voting is available through absentee ballot.

Your Rights as a New Jersey Voter are as Follows:

- To vote if you have registered within the correct timeframe.

- To have questions concerning voting procedures answered and to receive assistance if needed.
- To vote without being intimidated, threatened, or coerced.
- To vote if you are eligible to do so even if you do not bring an ID to the polls.
- To vote using a provisional ballot if your registration comes into question.
- If you feel that your rights are violated or you witness a violation of rights in the registration or voting process, please contact the New Jersey Division of Elections at (609) 292-3760.
- Your vote is private – The ballots are processed in such a way that your identity will not be distinguishable from your ballot.
