When and Where to Vote:

- Election Day is Tuesday, November 6, 2012.
- Polls are open from 6:30 a.m. to 7:30 p.m.

How to Register to Vote:

- To register, print the voter registration form from clicking [here](#), and mail it to your local election authority.
- Re-register to vote if you have moved, changed your name, or would like to declare an official party affiliation. If your voter registration information has not changed, you do not need to re-register.
- Registration must be received by October, 9, 2012.

What to Bring on Election Day:

- Bring a photo ID with your current address, such as an Ohio driver's license, your state ID, or a US Passport.
- If you do not have a photo ID with a current address, bring two IDs that contain your name and address, such as a utility bill, a bank statement, a paycheck, etc.
- You cannot be turned away from voting because you did not bring proper identification. If you do not have a proper ID, you can vote using a provisional ballot.

Absentee Voting:

- All registered voters are eligible to vote absentee.
- Request an absentee voting application by clicking [here](#), and mail it to your local election authority.
- Absentee ballots can be requested as early as January 1, 2012.
- Ballots must be received by 7:30 p.m. on November 6, 2012.
- Voters are strongly encouraged to go to the polls to vote if possible.

Early Voting:

- All registered voters are eligible for early voting in-person.
- Early voting begins on October 2, 2012 until 6:00 p.m. on November 2, 2012.

Your Rights as an Ohio Voter are as Follows:

- To vote if you have registered by October 9, 2012.
- To have questions concerning voting procedures answered and to receive assistance if needed.
- To vote without being intimidated, threatened, or coerced.
- To vote if you are eligible to do so even if you do not bring an ID to the polls.

Due to CAIR's 501(c)3 status, CAIR does not endorse any specific candidate or campaign and cannot give advice about how you should vote. Major newspapers may produce a guide to candidate positions.



- To vote using a provisional ballot if your registration comes into question.
- If you feel that your rights are violated or you witness a violation of rights in the registration or voting process, please contact the Ohio Secretary of State Elections Division at (614) 466-2585.
- Your vote is private – The ballots are processed in such a way that your identity will not be distinguishable from your ballot.
