When and Where to Vote:

- Election Day is Tuesday, November 6, 2012.
- Polls are open from 7:00 a.m. to 7:00 p.m.
- Find your local polling station by clicking [here](#).
- Here are some other ways to find your polling place:

such as a utility bill, a bank statement, a paycheck, etc.

- You cannot be turned away from voting because you did not bring proper identification. If you do not have proper ID, you can vote using a provisional ballot.

How to Register to Vote:

- To register, print the voter registration form by clicking [here](#), and mail it to your local election authority.
- Re-register to vote if you have moved, changed your name, or would like to declare an official party affiliation. If your voter registration information has not changed, you do not need to re-register.
- Registration must be received by October 12, 2012.

What to Bring on Election Day:

- Bring a photo ID with your current address, such as an Oklahoma driver's license, your state ID, or a US Passport.
- If you do not have a photo ID with a current address, bring two IDs that contain your name and address,

Absentee Voting:

- All registered voters are eligible to vote absentee.
- Request an absentee voting application form by clicking [here](#), and mail it to your local election authority.
- Absentee ballots can be requested until 5:00 p.m. on October 31, 2012.
- Ballots must be mailed or delivered in person and received by 7:00 p.m. on November 6, 2012.
- Voters are strongly encouraged to go to the polls to vote if possible.

Early Voting:

- All registered voters are eligible for early voting.
- Early voting takes place at your local election authority on the following dates:
 - November 2, 2012 from 8:00 a.m. to 6:00 p.m.
 - November 3, 2012 from 8:00 a.m. to 1:00 p.m.
 - November 5, 2012 from 8:00 a.m. to 6:00 p.m.

Your Rights as an Oklahoma Voter are as Follows:

- To vote if you have registered by October 12, 2012.
- To have questions concerning voting procedures answered and to receive assistance if needed.
- To vote without being intimidated, threatened, or coerced.
- To vote if you are eligible to do so even if you do not bring an ID to the polls.
- To vote using a provisional ballot if your registration comes into question.

Major newspapers may produce a guide to candidate positions.

- Your vote is private – The ballots are processed in such a way that your identity will not be distinguishable from your ballot.
